## 1. WRAM/MCBA Surcharges and Surcredits

The purpose of the Water Revenue Adjustment Mechanisms (WRAMs) and Modified Cost Balancing Accounts (MCBAs) (together, WRAM/MCBA) is to track water revenues and production-related costs as part of a comprehensive conservation framework adopted by the Commission and implemented in 2008. The net balance in a WRAM/MCBA account represents an over-collection or under-collection of the revenues authorized by the Commission.

Each year, the "net" WRAM/MCBA balance for an area is "amortized," meaning that surcharges or credits are applied to customer bills to bring the balance back to zero.

The "WRAM surcharge" for metered customers is a charge that is applied to each 100 cubic feet (or Ccf) of water usage. The "WRAM credit" is a fixed credit that is applied on a monthly basis, and is identified in the table below as a negative number.

## 2. Pension Cost & Healthcare Cost Balancing Accounts

The purpose of the Pension Cost Balancing Account (PCBA) is to true up the difference between actual pension costs and those that were adopted by the CPUC for calendar years 2020-2022. Actual pension costs exceeded adopted costs for this period, so surcharges will be applied, with a per-CCF surcharge (per 100 Cubic ft.) for metered customers, and a fixed surcharge per service for flat-rate customers. Surcharges vary by ratemaking area and will be in effect for a period of 12 months (except for a lump-sum charge for Travis).

The purpose of the Healthcare Cost Balancing Account (HCBA) is to true up the difference between actual healthcare costs and those that were adopted by the CPUC for the calendar years 2020-2022. Adopted healthcare costs exceeded actual costs for this period, so a fixed sur-credit will be applied to each service connection. Sur-credits vary by ratemaking area and will be in effect for a period of 12 months (except for a lump-sum credit for Travis).

## 5(a). Interim Rate Memo Account True-Up

Due to the delay in setting final rates approved in D.20-12-007, the Commission authorized interim rates for a period of 13 months from January 1, 2020 through January 31, 2021 (Interim Period). The surcharges below reflect the difference between the interim rates on customers' bills since January 1, 2020, and the final rates that would have been in effect during the 13-month Interim Period.

For metered customers, a surcharge (per 100 Cubic Feet, or CCF) will be applied based on water usage. For flat rate customers, a fixed surcharge per month will be applied to each service. These surcharges will be in effect for a period of 13, 18, 24 or 36 months, depending upon the district.
