Summary

Cal Water submits this advice letter to request the removal of three parcels from its Mid-Peninsula system's service area map. Furthermore, Cal Water would like to request the addition of a single parcel to its Mid-Peninsula system's service area map.

Discussion

MPWD recently alerted Cal Water to some overlap in its service area boundaries. This resulted in Cal Water conducting a field review of its Mid-Peninsula service area. The review noted three parcels included in this service area that Cal Water does not serve and a parcel that Cal Water has been serving but is not included in the service area map. The updated service area map reflects the removal of the following three parcels: 80 Glen Way, 295 Old County Rd, and 299 Old County Rd. It also notes the addition of the single parcel, 585 Bragato Rd., to the respective service area map.

Authority

Cal Water submits this as a Tier 2 advice letter according to General Order 96-B, Water Industry Rules 7.3.2(8) and 8.1.

Requested Effective Date

Cal Water requests that the attached tariffs in this Tier 2 advice letter become effective on **February 20, 2025.**

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided such a protest may not be made where it would require relitigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest. A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. Cities and counties requiring Board of Supervisors or Board of Commissioners approval to protest should inform the Water Division within the 20-day protest period so a late-filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on. The advice letter process does not provide for any responses, protests or comments, except for the utility's reply, after the 20-day comment period.

Replies: The utility shall reply to each protest and may reply to any response. Each reply must be received by the Water Division within 5 business days after the end of the protest period and shall be served on the same day to the person who filed the protest or response. If you have not received a reply to your protest within 10 business days, contact California Water Service Company at (408) 367-8200 and ask for the Rates Department.

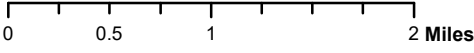
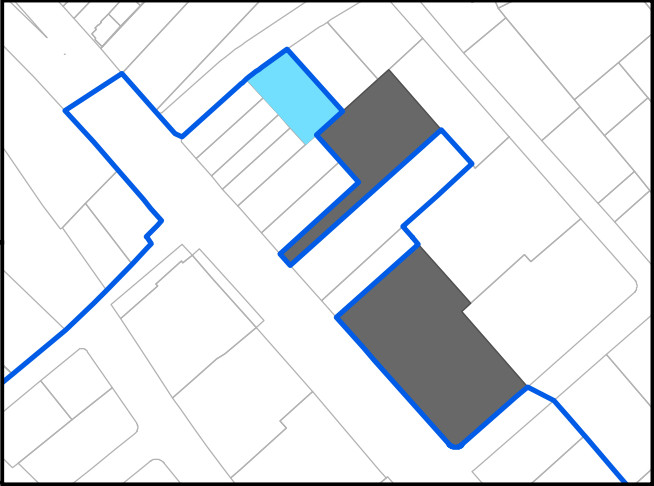
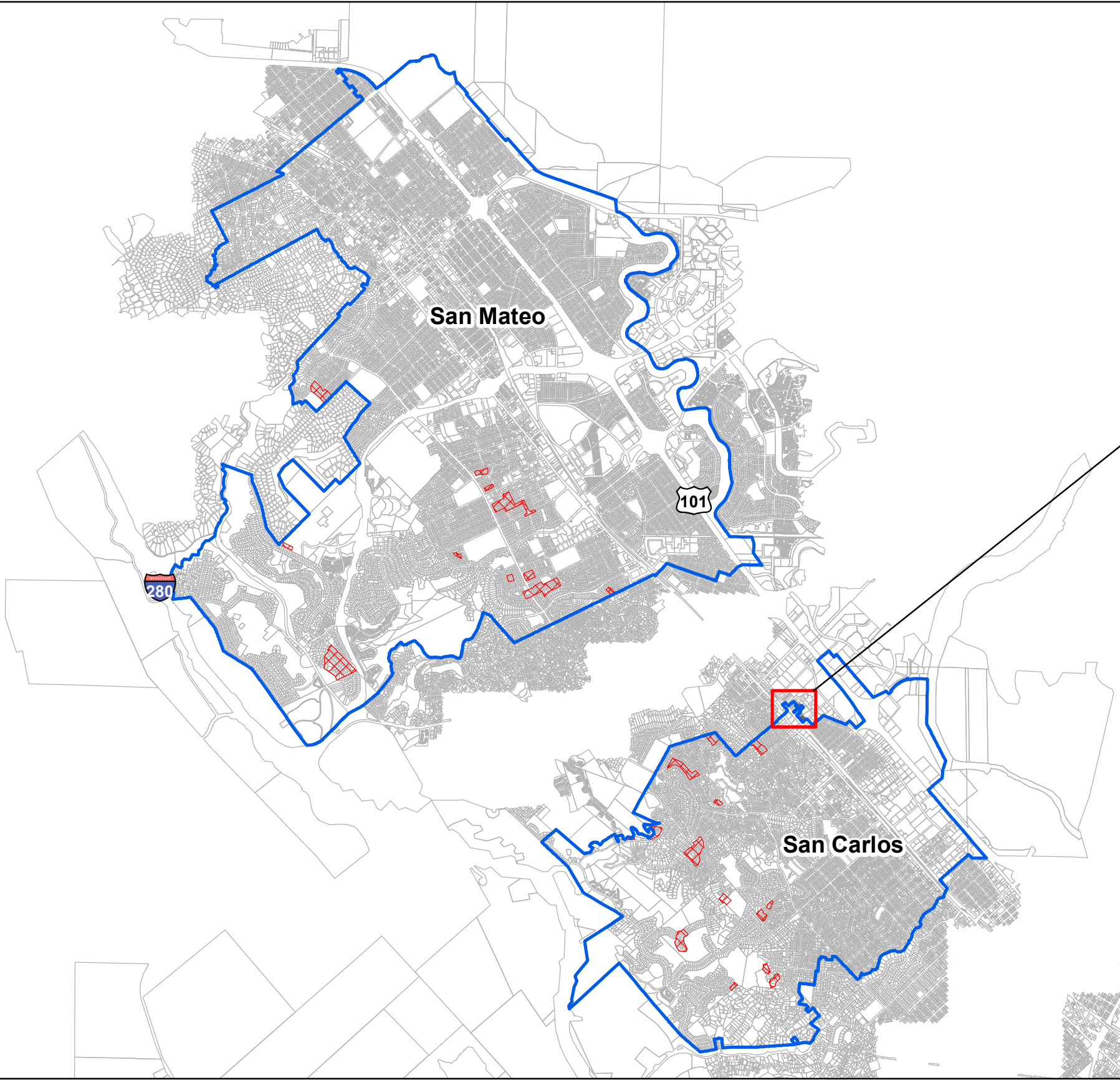
